

# APPLICATION FOR THE OMAHA PHILATELIC SOCIETY FALL STAMP SHOW & BOURSE

**September 19<sup>th</sup> and 20<sup>th</sup>, 2026**

The Omaha Philatelic Society (OPS) fall 2026 Stamp Show will be held at the Metropolitan Community College South Omaha Campus on Saturday, September 19 and Sunday, September 20, 2026. The bourse, sponsored by the OPS, will be open to the public from 9:30 am to 4:30 pm Saturday, 9:30 am to 4:00 pm Sunday. The Sponsor will provide the contracted table space with suitable back tables, chairs, and publicity. Dealer must supply own table coverings, table lamps, extension cords, and other aids. Dealer set-up will be on Friday, September 18, from 9:00 am to 5:00 pm.

The Sponsor is simply providing table space and services as stated above and is not responsible for any loss, damage, or injury that might be sustained by those assigned space in this bourse, to their employees or property, from any cause whatsoever, prior to, during, and/or following the bourse. Event security will be provided by campus police.

**Understanding and in agreement with the above, application is hereby made for bourse space at the Omaha Philatelic Society Fall 2026 Stamp Show on September 19<sup>th</sup> and 20<sup>th</sup>:**

**A deposit of \$150 must be submitted with this signed contract to reserve table space. The deposit will be used to pay for the first table. Payment of all remaining table fees is required prior to commencing setup.** Please make checks payable to **Omaha Philatelic Society** and mail to the address below. Dealer's check will be returned if application is not accepted, e.g. due to space limitations.

**Cancellation:** If Sponsor cancels stamp show, Sponsor will refund all table fees & deposit. Sponsor has no further liability. If Dealer cancels, Sponsor will refund all table fees & deposit if written cancellation from Dealer is received by Sponsor more than 30 days prior to opening day, or if table space is subsequently re-rented by Sponsor. If Dealer's written cancellation is not received by Sponsor more than 30 days prior to opening day, the deposit will be forfeited, and remaining table fees will be refunded.

It is agreed that I, as a participating Dealer, will abide by all the rules and regulations of Sponsor pertaining to the Stamp Show. I will not vacate my bourse space prior to show closing time without permission from the Stamp Show Chairperson. I will take care to avoid damage to venue property. I release the Sponsor and all of its members from all claims arising from any loss, damage or other type of injury associated with participation in the stamp show. It is further agreed that table space assigned to me will not be sublet, shared, or assigned to a third party, and that I will keep my materials within the space assigned to me.

It is agreed that any decision by the stamp show Chairperson interpreting this contract is final. The Stamp Show Chairperson will decide any matter not covered by these provisions.

The Signature of both the Dealer and the Stamp Show Bourse Chairperson constitute a contract in accordance with the terms stated herein.
